Employment opportunities for international students are limited by regulations of the United States Citizenship and Immigration Services/Department of Homeland Security (USCIS/DHS) and the Department of State (DOS).

F-1 and J-1 students who are maintaining status may work part-time on campus while classes are in session. "Part-time" means 20 hours or less per pay week (Friday through Thursday for UF, Thursday to Wednesday for Gator Dining, and Monday – Friday for the UF Bookstore; *please verify/confirm the work week with employer prior to starting employment*).

***F-1** students do not need specific authorization to work on-campus; it is automatically allowed within the F-1 regulations.

****J-1** students need written authorization from their International Student Adviser or Responsible Officer of their exchange visitor program prior to being able to work on campus.

NOTE: Off-campus employment, whether paid, unpaid/volunteer, for both F-1 and J-1 is strictly prohibited without first applying for and receiving specific written authorization on the student's I-20 (F-1) or DS-2019 (J-1) or application to USCIS/DHS resulting in an Employment Authorization Document.

FALL/WINTER BREAK 2017

Fall 2017 classes end 12/6/2017.

A student who ...

is enrolled Fall 2017, and
expects to *graduate December 2017*

... is allowed to work over 20 hours on campus during the Fall/Winter break, from 12/7/2017 - 12/15/2017.

Fall 2017 Graduation is on 12/16/2017 for most students.

A student who ...

is enrolled Fall 2017, and
will not *graduate December 2017, and* expects to *register in Spring 2018*

... is allowed to work over 20 hours on campus during the Fall/Winter break, from 12/7/2017 - 1/7/2018.

Spring 2018 classes start 1/8/2018.

SPRING BREAK 2018

Spring Break 2018 is from 3/3/2018 – 3/10/2018.

A student who ... 1) is enrolled Spring 2018

... is allowed to work over 20 hours on campus during the Spring break, from 3/3/2018 - 3/10/2018.

SUMMER BREAK 2018

Spring 2018 classes end 4/25/2018.

A student who ...

is enrolled Spring 2018, and
expects to *graduate May 2018*

... is allowed to work over 20 hours on campus during the spring, from 4/26/2018 - 5/4/2018.

Spring 2018 Graduation is on 5/5/2018 for most students.

A student who ...

 is enrolled Spring 2018,
will not graduate May 2018, and
expects to register in Summer 2018 to graduate in Summer 2018

... is allowed to work over 20 hours on campus during the summer, from 4/26/2018 - 8/10/2018.

Summer 2018 Graduation is on 8/11/2018 for most students.

A student who ...

 is enrolled Spring 2018,
will not graduate May 2018 or August 2018, and
expects to enroll in Fall 2018 (whether or not they enroll in Summer 2018)

... is allowed to work over 20 hours on campus during the summer, from 4/26/2018 - 8/21/2018.

Fall 2018 classes start 8/22/2018.
